#### Spring/Summer 2020:

SCNH is offering the following Freestyle skating sessions at the Whitestown Arena this spring/summer for registered USFS freestyle skaters meeting the test criteria. **OPEN:** must have passed Pre-Pre MIF.

**Thursday Split Sessions! Low** (6 - 6.55pm): Badge Pre-FS through not passed Preliminary FS **Mid/High** (6.55 - 7.50pm): passed Preliminary FS.

ALL Exceptions are subject to advance Board approval.

Contract skaters will have priority for drop-in spots at start of sessions. Non-contract drop-in rate is \$20/session. Contract skater drop-in rate is \$15/session. A maximum of 20 skaters will be allowed.

A non-skating adult must sign up to monitor 1 day/session/skater to receive make-ups. See "Monitor Signup" on SCNH.org website.

Skaters should use a single registration form to indicate chosen sessions for all packages – package prices/times are different for each season. Skaters will be allowed limited makeups per season, once monitoring obligations are fulfilled.

\$10 DISCOUNT IF SPRING REGISTRATION PAID IN FULL BY FEBRUARY 28th.

Please indicate probable plans for June and summer ice with spring registration—changes can be made prior to start of session, space permitting.

50% of spring package is due with registration. Final spring payment must be paid no later than the skater's first day on spring ice. Deposits (50%) for June and summer packages are due May 1<sup>st</sup>. Final June and/or summer payment is due prior to skater's first day of June and/or summer ice. No skater may skate without their contract being paid in full for that season. No pro-rating of sessions. No refunds after start of season. **Remember USFSA membership must be renewed by July 1<sup>st</sup>.** 

These sessions will be held only if there are sufficient pre-registrations to cover the ice costs. If the club does not receive sufficient contracts, sessions will be modified/cancelled. SPRING LATE FEE (\$20) applies after March 20th.
